Millennium 6-12 Collegiate Academy faculty and staff are enthusiastically looking forward to our annual class trips. This year the Eighth Grade will be traveling to **Islands of Adventure in Orlando Florida, on Monday, May 21, 2018**. Buses will begin loading at 4:45am in front of **Challenger Elementary School** (N.W. 94th Avenue, next door to Millennium) and leave shortly thereafter. **Students should arrive by 4:45am**. Parents are responsible for the transportation of their children to and from school on the day of the trip. Students not participating in the field trip are expected to be in attendance, as Monday May 21st is a regular school day. At the end of the day, parent pick up will be at the same location as the drop off and promptly at 9:30pm.

Students will be permitted to attend the end of the year trip if:

- **They do not have any disciplinary referrals from April 2nd through May 21st**
- **They have completed all consequences prior to the day of the trip including, but not limited to, before school detentions, lunch detentions, and class assignments.**
- **They have met all obligations to the school including the return of library books. Students with outstanding obligations will not be permitted to attend prior to paying off their obligation.**
- **Students must be passing at least 4 out of 6 classes and have satisfactory conduct to be eligible for the trip.**
- **They have returned all textbooks by May 14, 2018. Textbooks will be available for check in and check out after this date.**

The cost of the trip is \$150.00 per student. This price includes the cost of the bus, field trip shirt, admission to Islands of Adventure, and a lunch voucher to be redeemed at the park. Students must have money for additional food and expenses. **Money for the trip will be collected online beginning Thursday, March 1, 2018 and ending Saturday, March 31, 2018. If seats are available, cash collection will be on April 4th and April 5th ONLY in the cafeteria from 8:30am to 9:20am.** Due to limited space, spots will be filled on a first come first served basis. Once the busses are full, money will not continue to be collected, yet, students may be placed on a waiting list. Cash payments must be made in cash or by money order and must be accompanied by the permission slip attached to this letter. Personal checks will not be accepted. **NO REFUNDS WILL BE ISSUED.** Also, due to the package price of this trip, no annual passes can be used for the trip. **If a student receives a disciplinary referral between April 2nd and May 21st, they will not be permitted to attend the trip with the school, but they will receive their ticket for the park at 9:30am on May 21, 2018 (the ticket normally expires within a short time after the trip).**

School rules will be strictly enforced while on the Islands of Adventure trip. Additionally, students who steal, or are severely disruptive in the park may be arrested and their parents will have to pick them up in Orlando. Students must wear the Millennium Collegiate Academy trip shirt provided, during the entire field trip. Bottoms and shoes must comply with the Broward County School Board Dress Code as stated in Policy #5006. An assembly will be held prior to the field trip to discuss procedures, meeting places, etc. If you have any questions, please contact your child's team leader at (754) 322 – 3900.
